**TERMS AND CONDITIONS**

Unless otherwise stated, the Buyer and the Seller agree as follows:

1. The Buyer shall take delivery of the travel trailer from the Seller's premises within thirty (30) of the Estimated Delivery/Pick-up date, unless other arrangements are agreed to beforehand.
2. At or before delivery/pick-up the Buyer shall pay the Seller the balance of the purchase price shown as "Balance Due" above. Payment must be made by: Cash, Personal Check, or Bank Check.
3. If the travel trailer is delivered to the Buyer by a vehicle transport provider, the buyer shall pay for such service directly and will be wholly responsible for taking delivery on the selected delivery date.
4. Where the Buyer refuses or fails to take delivery of the travel trailer within 30 days of the Estimated Delivery/Pick-up Date, the Seller may terminate the Contract by written notice to the Buyer. Thereafter any deposit previously paid or payable by the Buyer to the Seller in an amount not exceeding 50% of the total purchase price of the travel trailer shall be forfeited to the Seller.
5. If the Seller has not delivered the travel trailer to the Buyer within thirty (30) days of the estimated pick-up/delivery date, the Buyer may by notice in writing to the Seller rescind the Contract.
6. Where this contract is lawfully rescinded due to inability of the Seller to produce the trailer by the agreed upon date, the Seller shall refund any and all monies paid by the Buyer.
7. The Seller shall make best efforts to provide the travel trailer by the estimated pick-up/delivery date, but shall not be liable to the Buyer for any damage or loss whatsoever arising either directly or indirectly from any such delay or failure of delivery.
8. Small variations in the finish of the travel trailer can occur particularly with regards to the aluminum skin, powder coating or other materials or components, especially those outside of the direct control of the Seller.
9. The Buyer has agreed to enter into this contract knowing that this travel trailer is individually built and that there are variances from the travel trailer on which the purchase decision was made. Furthermore, the Buyer acknowledges that he is aware that no two travel trailers are identical in terms of final finish.
10. Any addition to or variation of these terms and conditions will have no effect unless made in writing and signed by the parties to this contract.
